# ■ This Year's Laureate: Jerry A. Shields, MD

The Board of Trustees of the Academy is proud to announce **Jerry A. Shields**, **MD**, as the recipient of the Laureate Recognition Award for 2014.

Dr. Shields is director of the Wills Eye Hospital Ocular Oncology Service (which he established in 1974) and professor of ophthalmology at Thomas Jefferson University in Philadelphia. His main research focus is on choroidal melanoma and retinoblastoma. and he has devoted more than 40 years to advancing the early diagnosis and treatment of ocular cancer. In the treatment of these cancers, Dr. Shields and his team have improved local irradiation, local surgical resection, laser photocoagulation, thermotherapy, and chemotherapy. His work on these procedures has saved many eyes that otherwise would have been removed. Dr. Shields has served on editorial boards for the American Journal of Ophthalmology, British Journal of Ophthalmology, Cancer, Retina, Journal of Pediatric Ophthalmology, and numerous others. He has authored or coauthored more than 1,300 original articles in scientific journals, 550 textbook chapters, and 13 textbooks, including the Atlas of Intraocular Tumors and Atlas of Eyelid, Conjunctival, and Orbital Tumors.

Dr. Shields was an organizer and first president of the International

Society of Ocular Oncology, president of the Ophthalmic Club of Philadelphia, treasurer and president of the Macula Society, and president of the medical staff of Wills Eye Hospital. He has received more than 40 awards for his contributions to the field, including the National Physician of the Year Award for Clinical Excellence from Castle Connolly in 2013. Additionally, in 2012, the Asia-Pacific Academy of Ophthalmology established the Jerry Shields Lecture, which will be presented at its annual meetings.

In recognition of Dr. Shields' contributions to ophthalmology, the Academy will honor him as the 2014 Laureate during the Opening Session at AAO 2014.



# D.C. REPORT: Take Advantage of Congress' August Recess

his month, Congress departs Capitol Hill for an extended break from legislating. Lawmakers will use the time to meet with constituents, hold town hall meetings, and visit local organizations and businesses. The recess serves as an opportunity for ophthalmologists to advocate for the Academy's legislative agenda, promoting change in Washington, D.C., that will benefit patients and the profession.

The Academy provides support. The Academy is taking advantage of lawmakers' visits to their home districts. Its Congressional Advocates—Academy members who have relationships with members of Congress—are meeting with lawmakers throughout the month. The Academy is providing Congressional Advocates with background materials, one-on-one support, and assistance in arranging the meetings. According to a study by the nonpartisan, nonprofit Congressional Management Foundation, such meetings are one of the most influential ways to interact with members of Congress.

Influencing legislation. During tours of ophthalmology practices and town hall meetings, ophthalmologists and lawmakers are having open dialogues about the need to permanently repeal the sustainable growth rate formula used to calculate Medicare physician payments. Academy members are also urging representatives to cosponsor legislation requiring all health care providers to disclose their professional credentials in their advertising and to their patients during office visits, with the intent of mitigating and ending patient confusion over who is providing their medical care.

**Get involved.** The Academy's goal is to have at least one Congressional Advocate in every legislative district. Support ophthalmology's legislative agenda during the August recessattend a town hall meeting with your representative or senators, or schedule a meeting with them either at your practice or in their district office.
